Your Qualifying RAPIDPASS Clean Screen Vehicle Emissions Inspection Record

Dear

Your vehicle has been identified as **CLEAN** by **RAPIDPASS**, Air Check Virginia's on-road, drive-through emissions inspection option. Authorized by the **Virginia Department of Environmental Quality (DEQ)**, **RAPIDPASS** allows drivers of very clean vehicles to have their emissions inspected on the road during normal driving routines. Your vehicle has been recorded as clean by **RAPIDPASS** thereby satisfying your emissions inspection requirement. To register your vehicle with this **RAPIDPASS** record, simply pay the inspection fee of \$28.00 using one of the options below. Once payment is received, your vehicle's emissions inspection report will be electronically transmitted to the Virginia Department of Motor Vehicles (DMV) and you can then proceed with your vehicle registration renewal online, via the mail or at DMV. This is the same \$28.00 fee you would pay if you took your vehicle to a traditional emissions inspection station.

To complete your emissions inspection process, follow the simple steps below.



ONLINE

Within 120 days of the vehicle registration expiration, visit www.RAPIDPASS.org and enter the vehicle information and Clean Screen ID number listed above. Using the secure online credit/debit card payment option, pay the \$28.00 emissions inspection fee. **Print the receipt and use the confirmation to renew the vehicle registration online, via mail or at DMV.**

Detach the form below and mail it along with a check or money order in the amount of \$28.00 payable to **RAPIDPASS** Virginia. Once you receive confirmation of your payment, use the confirmation to renew your vehicle registration online, via mail or at DMV.
