

Public Notice – Environmental Permit

PURPOSE OF NOTICE: To seek public comment on a draft permit from the Department of Environmental Quality for the withdrawal of ground water in Hanover, Virginia.

PUBLIC COMMENT PERIOD: January 20, 2016 to February 19, 2016

PERMIT NAME: Groundwater Withdrawal Permit issued by DEQ, under the authority of the State Water Control Board

APPLICANT NAME, ADDRESS AND PERMIT NUMBER: Legacy Park Home Owners Association, 901 Westerra Parkway, Suite 100, Richmond, VA 23233, GW0022100

NAME AND LOCATION OF WATER WITHDRAWAL: Legacy Park Subdivision; 6504 Pole Green Road, Mechanicsville, VA 23111

PROJECT DESCRIPTION: Legacy Park Home Owners Association has applied for a new permit for the Legacy Park Subdivision in Hanover, Virginia. The permit would allow the applicant to withdraw an average of 16,986 of gallons per day. The groundwater withdrawal will support the community's landscape irrigation needs. The proposed withdrawal will utilize the Columbia aquifer at a depth between 0 feet to 60 feet below the land surface at the withdrawal site. An aquifer is a body of rock or layer of sediment in the ground in which ground water is stored and transported. DEQ has made a tentative decision to issue the permit.

AFFECTED AREA: The radial distance from the wells to where computer modeling predicts the aquifer may experience one foot of drawdown due to the withdrawal is illustrated on a map that can be viewed at <http://www.deq.virginia.gov/Programs/Water/WaterSupplyWaterQuantity/GroundwaterPermitting/PublicNoticesIssuedPermits.aspx>

HOW TO COMMENT AND OR REQUEST A PUBLIC HEARING: DEQ accepts comments and requests for public hearing by e-mail, fax or postal mail. All comments and requests must be in writing and be received by DEQ during the comment period. Submittals must include the names, mailing addresses and telephone numbers of the commenter/requester and of all persons represented by the commenter/requester. A request for public hearing must also include: 1) The reason why a public hearing is requested. 2) A brief, informal statement regarding the nature and extent of the interest of the requester or of those represented by the requestor, including how and to what extent such interest would be directly and adversely affected by the permit. 3) Specific references, where possible, to terms and conditions of the permit with suggested revisions.
