Subject: Department of Environmental Quality Service Area Alignment

The purpose of this memo is to inform you about changes in the service area boundaries for the Stormwater Management and Erosion and Sediment Control Programs previously administered by the Department of Conservation and Recreation's (DCR) Regional Offices.

As you know, during its 2013 Session the Virginia General Assembly passed legislation making the Department of Environmental Quality (DEQ) the Commonwealth's lead agency for managing stormwater and related non point source pollution programs effective July 1, 2013. The changes to the service area boundaries for the Stormwater Management and Erosion and Sediment Control Programs result from merging the seven previous DCR service areas into the existing six DEQ Regional Office service areas.

As part of the transition of these programs into DEQ and its regional offices, effective November 1, 2013, the Stormwater Management and Erosion and Sediment Control Programs will be administered under DEQ's established service area boundaries. Please find the attached listing showing the localities that are affected by the change and the associated Regional Office contact information. Information also is available at DEQ's website <http://www.deq.virginia.gov/>.

This change will not affect the service provided to you (although it may impact a few specific staffing responsibilities within these programs). Additionally, you should note this change only affects the Stormwater Management Program (including Local Stormwater Program Development Grants) and the Erosion and Sediment Control Program and does not affect any other DEQ programs.

The DEQ looks forward to continuing to grow our relationship with you in stormwater management and erosion and sediment control. We appreciate your patience as we work through this transition period. Please know that DEQ is committed to continue to provide you the best service to meet your needs while conducting the business of protecting the natural resources of the Commonwealth in an effective and efficient manner.
