





- Virginia Department of Health, Division of Waste Water Engineering (marina database)
- Federally-documented vessels (U.S. Coast Guard)*



SUMMARY

- Creeks compromised by bacterial impairment, low dissolved oxygen, and conditions that impair growth of aquatic plants
- Creeks fail to meet water-quality standards
- Pumpout facilities and dump stations available to serve the estimated vessel population using these creeks
- NDZs protect low-flushing tidal tributaries
- Virginia's Department of Environmental Quality deems the creeks excellent candidates for No Discharge Zone designation
