

License Review Classes:

The Department of Environmental Quality, in cooperation with listed educational institutions, presents workshops to assist wastewater treatment plant operators and trainees to prepare for the wastewater licensure examinations. Course dates, locations, registration requirements, fees, contacts and other pertinent information are provided. For information regarding a specific program, call the contact person listed in the schedule for that location.

Course Approval:

All wastewater programs listed in this announcement are conducted using course materials prepared by the Operator Training Program of the Department of Environmental Quality and approved by the State Board for Waterworks and Wastewater Works Operators and On-site Sewage System Professionals for use as substitution for required operating experience as permitted by Board regulations.

Classes taught at locations other than community colleges will earn training credits, but not college credits.

Cancellation:

All classes are subject to cancellation in the event of insufficient registrations. In the event a class must be cancelled, only those who have registered will be notified of the cancellation. **Persons traveling long distances to attend should confirm course availability prior to leaving home.**

Inclement Weather:

The inclement weather policy of the host institution at which the program is held will be observed.

Course Registration:

All participants must register with the host community college. **Most colleges require registrations and associated fees be submitted prior to the start of class.** In some instances colleges will allow registrations on the first day of class on a space available basis.

Since classes may be cancelled for lack of registrations, it is important to contact the college and register at least 5 business days prior to the first day of class.

Course Costs:

All wastewater licensure review classes require that participants have one set of the Basic or Advanced Wastewater Licensure Review manuals (5th Edition). Some programs may require additional reference materials. This is indicated by an asterisk (*) following the program title. All reference materials can normally be purchased at the institution's bookstore. The Basic and Advanced Wastewater Licensure Review manuals can also be purchased from the Department of Environmental Quality. For purchasing information contact the host institution or DEQ program contact.

Refunds:

The host institution's refund policy applies. If you are unable to attend after registering for a program contact the institution immediately for withdrawal and refund procedures.

Water Treatment Training Programs:

The Department provides information on available water courses as a service to the sponsoring institutions and water plant operators. Contact the host institution to determine whether a water program is approved by the License Board.

Water programs may require purchase of additional reference manuals. When required, manuals can be purchased from the college bookstore. Contact the host institution for additional information.
