



## Virginia Facilities Accepting Friable and Non-Friable Asbestos Containing Waste Material

The Virginia Solid Waste Management Regulations (VSWMR), [9 VAC 20-81-620](#), and the National Emission Standards for Hazardous Air Pollutants (NESHAP) regulations, [40 CFR Part 61 Subpart M](#), contain standards for managing asbestos-containing waste materials (ACM) generated by asbestos mills, manufacturing, fabricating, and spraying operations, and for managing Regulated Asbestos Containing Material (RACM) generated in the course of demolition and renovation of installations, structures or buildings, or other waste-generating activities.

In order for any ACM to be accepted at a disposal site, transportation and packaging requirements (e.g. waste properly bagged and sealed) must be met. All ACM generated in a manufacturing, fabricating, or spraying operation, and all RACM generated in a demolition or renovation operation shall be disposed in a special purpose landfill or in a designated area of a sanitary landfill. Category I and Category II non-friable ACM may be disposed in a landfill applying daily soil cover, providing that the operator is notified and the landfill’s permit specifically authorizes acceptance of the waste. If the landfill’s permit does not specifically authorize for the waste to be accepted, the landfill may request approval to accept the waste by submitting a [Special Waste Disposal Request](#) to the regional DEQ office.

All asbestos waste should be placed and covered immediately to prevent exposure, and a record should be maintained in the landfill’s operating record of the mapped location (including elevation and coordinates) and quantity disposed. Safety precautions should always be taken to prevent physical injury, inhalation hazards, punctures, and other exposures if areas in the landfill need to be excavated or accessed at a later date for leachate seep repairs, installation or repair of gas wells, haul road construction, landfill mining, or other reason.

Below is a listing of all facilities that accept asbestos-containing waste materials. **Generators are advised to CONTACT THE DISPOSAL FACILITY OPERATOR IN ADVANCE to confirm site-specific acceptance and handling procedures.**

Please note that the [Virginia Department of Labor and Industry](#) (DOLI) must be notified of any asbestos abatement project greater than ten linear or square feet, and for essentially all demolition projects. Asbestos workers must be licensed by the [Virginia Department of Professional and Occupational Regulation](#) (DPOR).
